The BCRC Board of Directors recognized Paulette Miller recently for her twenty years of service as Executive Director of the Beaver County Rehabilitation Center. Ms. Miller became director on December 13, 1990.

According to Commora Woodfork, BCRC's longest active board member with 38 years of service, "When Paulette became director, she was filled with enthusiasm and that enthusiasm was passed on to the board." Ms Woodfork especially appreciates the lives that have been touched by Paulette's mission. She recalls one lady who said, "My son had been very down and had no motivation. However, he did a complete turnaround when he went to BCRC. He loves to go to work and he is like a new person." Ms. Woodfork believes that, "Paulette and the BCRC staff truly care about the people served by BCRC and it's obvious that the people sense that caring."

Along with bringing a sense of caring and enthusiasm to BCRC, John Francis, Board Secretary and 26 year member, says Ms. Miller is a "go-getter." He cites the numerous new programs and many grants that have caused the agency to grow and prosper. He feels that instead of playing it safe, "Paulette has been willing to try new things that have greatly benefited the people served by BCRC."

Seventeen year board member Arthur Cornell attributes BCRC's growth to Paulette's ability to anticipate trends and opportunities. He states, "The agency is constantly positioning itself to move forward and increase opportunities for the BCRC clients." Mr. Cornell also admires Ms. Miller's ability to juggle so many priorities at once. He says, "She reminds me of the guy who used to spin pie plates on the old Ed Sullivan show. He would go from plate to plate without dropping one."

Current president and 29 year board member Don Bolland has seen Paulette juggle numerous projects, "While always keeping the welfare of mentally and physically challenged individuals as her main priority." He states that, "Under the leadership of Paulette and the board, BCRC has grown from serving 60 clients to more than 700 today. We have expanded facilities and programs in an effort to meet the needs of the many persons with disabilities in Beaver County. We will always place our emphasis on the people that we are serving."

The Board of Directors, staff and her beloved clients would like to thank Paulette Miller for serving BCRC so well for the last 20 years. Paulette's tenure as executive director is the longest in the history of the Beaver County Rehabilitation Center. ■

## Follow-Along Program Aids Man's Dream

Rob Robinson found that his dream of having a family and a good job was in jeopardy. After eight years of employment at a mail-order prescription business, Rob reached a cross-road in his life. A change in demands at work threatened his job and his family's security.

For the last eight years Rob's job entailed entering extensive information on each prescription into a data base as a means of processing a mail order. Things like the person's billing address, shipping information, correct names of medication, number of pills, etc. had to be entered with a high degree of accuracy into the company computer. In addition to this accuracy, Rob received a daily report on his production from the previous day. This caused Rob to start each day worrying about the previous days' production. A high degree of productivity and accuracy were necessary to maintain his employment, but they also lead to a high degree of anxiety.

As a married man with responsibilities, Rob felt the stress of these new more stringent requirements. While being highly capable, the stress of living up to increased expectation caused Rob's job performance to suffer.

Rob had been placed in his job by BCRC's WIN services. Thanks to funding from the Community Service Block Grant of Beaver County Community Development, WIN was able to come to Rob's assistance in his hour of need. WIN's capable staff provided support and strategies that enabled Rob to meet production goals with the required degree of accuracy. More than anything, the confidence that WIN showed in Rob helped him to see past his anxieties to a successful job experience.

Both Rob and WIN are grateful to Beaver County Community Development for their steadfast support over the years for the employment follow along program that allows people to receive the support they need to maintain their employment in the community. ■
