



## BCRC Reaches Out to Senator Casey's Staff to Preserve 14(c)

Out of concern that one of BCRC's flagship programs, the Production Center, may be at risk, BCRC recently hosted Michael Gamel McCormick, Disability Policy Director for Senator Casey. Legislation, which passed the House and moved to the Senate in November, would phase out 14(c) special certificates which allow for BCRC's Production Center to provide employment as programming.

BCRC has successfully helped many individuals reach and maintain employment and fully supports a full array of employment options including apprenticeships, job sharing, job coaching, entrepreneurship, and increasing competitive opportunities. In spite of best efforts, however, this goal remains elusive for some individuals. For these individuals, the 14(c) certificate is an imperative and valuable option as it provides individuals with purpose, satisfaction and pride in their daily lives.

In October, BCRC hosted a Zoom conference call with McCormick. At that meeting, BCRC discussed the impact the 14(c) elimination would have on people receiving services at BCRC. This meeting led to an in-person visit by Mr. McCormick on November 9. Accompanying him were two additional members of Senator Casey's staff, Marlon Ferguson, the SWPA Regional Director and Robbie Matesic, Regional Representative. During the visit, BCRC staff presented information about services offered to clients, answered questions posed by Senator Casey's staff, and provided a hands on tour of the Production Center. Ms. Miller also requested that Senator Casey consider a "carve-out" option within the legislation that would allow for 14(c) certificate programs to continue if specific conditions are met. It is too soon to know what the outcome will be; however, there is still time to advocate for the 14(c) program by reaching out to your legislators. BCRC will be sending out additional information to staff and clients about ways they can advocate for the continuation of this important program.

Crews of four clients and one staff are contracted to clean a total of five buildings, five days each week. With the return, clients received an exciting raise to \$9.00 an hour while working on this contract.

BCRC Safety Director Laura Medarac shared, "BCRC staff and clients were incredibly thrilled to continue this 15-year or more partnership with the Housing Authority." Medarac says, "The staff and clients are really taking ownership to ensure that all supplies are organized for each site, laundry is completed, and all on-site tasks are completed." Staff and clients from Client Services, WINServices, and School to Work are collaborating and receiving cross-departmental training to fulfill the needs of this contract during these unprecedented times. All support staff have received specialized ACRE training provided by Virginia Commonwealth University. The ACRE training endorses competency in this intermediate step in prevocational services to enhance each individual's overall employability.

Medarac also shared that the Housing Authority managers have expressed joy to see our clients back and are pleased with the work that is being completed.

The Office of Developmental Programs (ODP) has a mission to support Pennsylvanians with developmental disabilities to allow them to achieve greater independence, choice, and opportunity in their lives. As part of this mission, ODP and in turn BCRC are committed to providing the necessary tools and resources to conduct quality investigations into incidents of abuse, neglect, and other significant events that occur in the lives of our clients.

Once an incident is reported the certified investigator springs into action conducting interviews of the involved parties and any witnesses and then, reporting their findings in a timely and objective manner. The certified investigator writes a report including their conclusions and determinations for corrective action.

The initial certification process consists of four parts; verification of applicant's general qualifications, taking an online prerequisite course, virtual Zoom sessions and assignments, taking quizzes, and passing an online examination. Karen, Laura and Krista all spent many hours studying for the course through Temple University and preparing to be certified by the Office of Developmental Programs as investigators.

## Zagorski Seeks to Bring Fulfillment to Aurora Participants

Ryan Zagorski, a Psychiatric Rehabilitation Practitioner at Aurora Services, is helping Aurora participants reach their dreams of community employment and independent living through his Life Skills classes.

Each Monday morning at Aurora Services, a young adult group eagerly engages in the Life Skills course, taught by Zagorski. With the help of technology and imagination, the classroom is alive with discussions on topics like procuring and furnishing a virtual apartment, budgeting, credit unions, credit cards, price comparisons, buying on sale and renting to own, saving money and the use of internet websites. Valuable skills such as learning to negotiate for a group consensus, and effective communication skills to hone in a more fulfilling independent life are practiced.

Ryan also does mobile one-to-one appointments for participants preparing to be in the community. Ryan works with students to utilize decision making skills to promote and express individualism and self advocacy during tasks like initiating conversations, ordering food, and making purchases in grocery stores. Exploring employment interests, job search skills, and visiting a potential employer are all on the agenda to support individual goals. Homework assignments include practicing how to sort clothes and do laundry which help participants become a more focused contributing member of a household by taking on daily tasks.

A break out group to teach cooking skills is planned for the future when COVID-19 restrictions are removed.

Zagorski's classes are helping Aurora participants break out of the status quo as they seek a more satisfying and fulfilling life.
